4b (Code: ) (Expenses \$ 996,114. including grants of \$ ) (Revenue \$ 276,105. ) Community Outreach - The Society provides basic veterinary care to underserved areas of the community and provides education to the general public regarding animal care, spay/neuter, and animals in need of adoption. In 2023, we helped 17,334 pets, which included completing or funding 8,443 spay/neuter surgeries.
