Animal Care - The Society provides for the general care, feeding, and adoption of animals. In 2024, 5,597 total pets were adopted and our live release rate was 95%.

Community Outreach - The Society provides basic veterinary care to underserved areas of the community and provides education to the general public regarding animal care, spay/neuter, and animals in need of adoption. In 2024, we helped 9,253 pets, which included completing or funding 2,941 spay/neuter surgeries.
